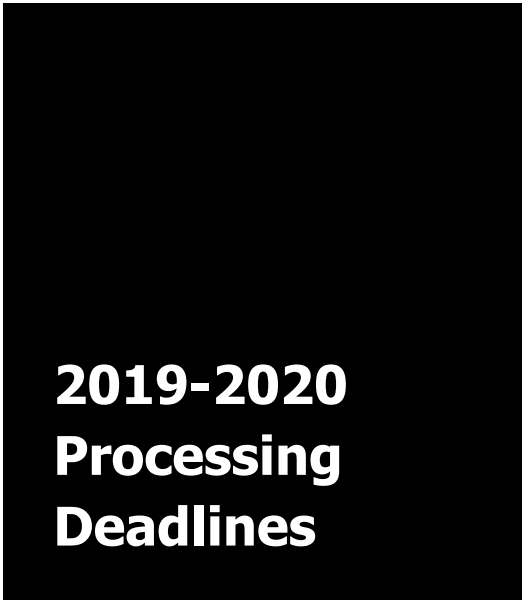
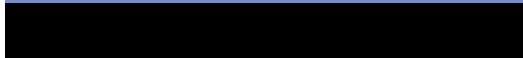

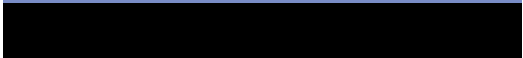

## FALL 2019 PELL DEADLINE

Students **NOT selected** for verification

- Not selected by the Department of Education/ Financial Aid Office
- No CUNY Edits
- No request for documentation from Financial Aid Office

To be eligible for FALL 2019 PELL, students' SAR information must show an ELIGIBLE EFC by their last day of enrollment. For students who complete or attend up to last day for Fall 2019 semester, the last day to submit documents for CORRECTION is Monday December 2, 2019. The last day to submit documents with NO CORRECTION needed is Friday, December 20, 2019

Students selected for verification

Students selected for verification have 120 days after their last day of enrollment. For students who complete or attend up to the last day of Fall 2019 semester, the last day to submit documents for CORRECTION is March 30, 2020

## Spring 2020 Pell Documentation Deadline

If you are NOT selected for verification, Friday May 8, 2020 is the last day to submit documents or make correction to your 2019-2020 FAFSA information.

If you are SELECTED for verification, Thursday August 6, 2020 is the last day to submit documents or make correction to your 2019-2020 FAFSA information

## Fall 2019 Direct Loan and private loan Deadline

The last day to submit a Direct Loan and private loan request is December 8, 2019

Note: 2019-2020 FAFSA data must be finalized (no correction required). The loan application/ Status change form must be completed in its entirety. If it is your first time requesting a loan, please make sure the Entrance Interview has been completed and is attached to your loan request

## Spring 2019 Direct Loan and private loan deadline

The deadline to submit a Direct Loan/ Direct Loan Status Change Form and Private Loan request is May 7, 2020

Please Note: You must meet the following criteria to be eligible for a loan: 2019-2020 FAFSA data must be finalized (no corrections required). Must be meeting satisfactory academic progress, enrolled in a minimum of at least 6 credits.

The Direct Loan processing form must be submitted by the deadline via your CunyFirst self-service account. No changes can be made to your applications beyond the deadline; therefore, we emphasize all questions be answered appropriately.

If it is your first time requesting a loan, please make sure that the Entrance Interview has been completed and the Master Promissory is signed.

No exceptions will be made after the Deadline date!
